- **Distance from the screen:** Candidates must maintain an appropriate distance from their screens that is compatible with the use of their headsets and that ensures that they may not use archived documents on their PCs or consult the web or databanks.
- **Account to access the platform:** For access to the platform to be used to remotely take the exam, candidates must always use the email address they have indicated in their application form.
- **Contactability of candidates:** Candidates must be constantly available on the mobile phone number indicated on the application form throughout their oral exam.
