The following are the modalities for taking the test:

- **Identification**
Candidates must be identified before the test begins, by showing their identification document in the video they have sent in advance to the office by mail, as requested in the communication calling for the document and the module confirming the correctness of the data given in the admission form.
- **Devices**
Candidates must guarantee a stable and adequate connection and the test must be undertaken by using a computer (desktop computer or notebook) with fully functioning videocamera switched on and clearly showing the candidate; moreover, to ensure better audio reception, candidates must equip themselves with a headset to use during the test.
- **Distance from the screen**
Candidates must maintain an appropriate distance from their screens that is compatible with the use of their headsets and that ensures that they may not use archived documents on their PCs or consult the web or databanks.
- **Account to access the platform**
For access to the platform to be used to remotely take the test, candidates must always use the email address they have indicated in their application form.
- **Link for candidates with specific timeslots**
The link received via email should be used solely to connect during the timeslot selected for the candidate on the day of the test.
- **Contactability of candidates with specific timeslots**
Candidates must be constantly available on the mobile phone number indicated on the application form throughout the timeslot allocated for their oral test.
